## Eugene Melvin Melchior II Scholarship Program

The Eugene Melvin Melchior II Scholarship Program is designed to address the financial needs of individuals impacted by incarceration. It is a benefit that will impact our communities as individuals are provided with growth opportunities.

- Right Road Scholarship for a returning citizen (formerly incarcerated) for higher education opportunities to become more marketable citizens of our community, which will lend itself to better employment opportunities.
- Eugene Melvin Melchior II Scholarship for a high school graduate, impacted by incarceration, ages 17-21, pursuing a higher education opportunity. This scholarship supports preventing generations of incarceration.

### Eligibility

The scholarship is only open to returning citizens (formerly incarcerated) and family members impacted by incarceration.

### Selection Criteria

Returning citizens must demonstrate remorse for their actions and a willingness to change. Family members must demonstrate hope in their future and strength to overcome setbacks. Applicants must complete our application and participate in an in-person or phone interview with the Failsafe Scholarship Education Committee to finalize the application process. They will be contacted directly to schedule the interview after the deadline date.

### Application Process

Applicants must write an essay about how they intend to use their field of study for the good of the community. Give us some insight into your background, why you chose your field, and any other information you feel is relevant. Your essay will be judged based on originality and creativity. Weight will be given to financial need, situational hardship, community service, and leadership potential.

- Essay length should be no more than 500 words. Upon submission, the essay becomes the property of Failsafe
- A brief biography and recent photo. The photo will be used for publicity purposes on the Failsafe website and social media platforms.
- Two Letters of Recommendation in support of your application for the Eugene Melvin Melchior II scholarship program. You may select anyone from your local community who you believe can best address your character, commitment to community service, and leadership qualities.

#### **Submission Deadline**

Applications are accepted January 21 through March 31.

#### **Accepting the Scholarship Award**

Once a candidate is notified of winning, the candidate has three days to respond and accept the scholarship award. If the selected candidate does not respond within the allotted time, another winner will be chosen. Once the winner(s) are selected, the scholarship(s) will be awarded at our annual 2<sup>nd</sup> Chance Hall of Change Gala and Scholarship program, at no cost to the recipient plus one.
